**ENTRIES AND FEES:** All competitors must be members of the El Toro International Yacht Racing Association. The annual membership fee for ETIYRA is \$15 and can be paid on the class website or upon entry at the event. There is no other entry fee. Sailors may enter at any time before 10:00 a.m. on April 4, 2009. The entry form is attached.

**ELIGIBILITY:** All sailors who are 15 or younger on April 4, 2009.

**EQUIPMENT:** All equipment used by a competitor (hull, sail, masts, boom, centerboard, rudder, etc.) must conform to the El Toro Class Rules.

**OVERVIEW:** The event will be a series of not more than five races. Weather permitting, the warning signal for the first race will be at 10:45 a.m. and no races will be started after 3:15 p.m. There will be a short break for lunch for competitors, instructors, and parents outside the Richmond Yacht Club clubhouse. **BRING YOUR OWN FOOD AND BEVERAGES.** The Race Committee will use a 5 min., 4 min., 1 min. starting sequence under RRS 26; competitors should bring their starting watches. **THIS EVENT IS THE FIRST IN A SERIES OF FIVE JUNIOR EL TORO REGATTAS DURING THE SPRING AND SUMMER OF 2009. EACH OF THE RACES IN THOSE FIVE REGATTAS WILL COUNT TOWARDS A JUNIOR SEASON CHAMPIONSHIP. HIGH POINT SCORING WILL BE USED.**
